2007 MIDDLE CLASS STAR REBATE PROGRAM
FREQUENTLY ASKED QUESTIONS

What is the 2007 Middle Class STAR Rebate Program?

The 2007 Middle Class STAR Rebate Program is an expanded property tax relief program that provides homeowners a benefit in the form of a property tax rebate check. The program provides two types of rebates:

- A Middle Class STAR rebate is available for homeowners who receive the basic STAR exemption on their property tax bill. These homeowners must apply to receive this tax relief, as the amount of the rebate is correlated to the homeowners' income levels. The program provides benefits to taxpayers on a sliding scale based on income, with benefits declining as income exceeds \$90,000 for upstate homeowners and \$120,000 for homeowners in the higher-cost New York City metropolitan region. Taxpayers earning more than \$250,000 are not eligible to receive a check.
- A rebate also is available for homeowners who are senior citizens 65-years or older and receive an enhanced STAR exemption on their property tax bills. No application is necessary. Enhanced STAR recipients will receive their check automatically.
- In either case, the rebate check is in addition to any tax relief homeowners receive as a reduction of their school tax bills under basic or enhanced STAR.

I'd like to get a rebate check. How do I apply?

If you receive the basic STAR exemption on your 2007-2008 school tax bill, you will receive a letter about the 2007 Middle Class STAR Rebate Program from the New York State Department of Taxation and Finance which will provide you with details on how to apply. The deadline to apply for your rebate is **November 30, 2007**. You can apply in one of two ways:

- Go to the Tax Department's Web site, www.nystax.gov, to complete and submit your online rebate application. It is free, fast and secure. You will receive an online confirmation as proof that the Tax Department received your application timely. **This is the quickest way to receive your rebate check.**

OR

- If you can't apply online, use the paper application, form DTF-179, which will be included with the letter provided by the Tax Department. You can also print a blank application from the Department's Web site or obtain an application from your local assessor's office. Complete all of the information and mail to the Tax Department at the address provided on the form.

If you receive enhanced STAR, no application is necessary.

What information do I need to apply for the rebate check?

The application requires only a few simple facts for completion:

- You will need the STAR code for your property, which is included with the letter you receive from the Tax Department. The STAR code is a six-character code, assigned by the Tax Department. This code will make it easy for the Tax Department to identify your property when you apply for your rebate. Simply transfer the STAR code to your online application. If you are using the paper application, the STAR code is already pre-printed on the form we mailed to you.
- You will need the names and social security numbers of all resident property owners and their spouses.
- You will need to verify that you and/or your spouse filed a New York State income tax return for 2005. Simply check the box if you have. (If you and your spouse were not New York State residents in 2005 and were not required to file a 2005 New York State income tax return, you will need the front page of your 2005 Federal income tax return.)

If you receive more than one notification letter and pre-printed application, please review the information on each letter. You should only apply for a rebate for a home that you owned on the date provided on the pre-printed application and that was your primary residence.

How do I qualify for the rebate program?

As a homeowner, you qualify if you:

1. Get the basic STAR property tax exemption for the 2007-2008 school tax year;

You can verify this by finding your basic STAR exemption on your school tax bill (if your home is outside New York City) or on your New York City Department of Finance Statement of Account (if your home is in New York City). If you received the notification letter from the Tax Department with the pre-printed application, you are enrolled in the STAR Program and are receiving a basic STAR exemption on your property tax bill.

2. Had a combined income (for all resident property owners and their spouses) for the 2005 tax year that was no more than \$250,000; and
3. Apply for your rebate with the Tax Department no later than **November 30, 2007**.

You do not qualify for a rebate check if you are a renter, business or for any second home that you may own.

How much will I receive as a rebate?

You can find calculated 2007 Middle Class STAR rebate amounts on the Tax Department Web site at www.nystax.gov.

Rebate amounts are determined based on a combination of factors, including the income bracket for your property, the tax rate for the school district where the property is located, and the city, village or town where the property is located.

The income bracket is determined by the taxpayers' affiliated income, which is the 2005 combined income (federal adjusted gross income less IRA distributions) for all resident property owners and their applicable spouses (whether or not they are owners). The rebate amount is based, in part, on the income bracket, with the rebate benefit declining as affiliated income rises.

The income brackets are:

Property Location	Income Brackets		
New York City Counties of Nassau, Suffolk, Westchester, Rockland, Orange, Dutchess and Putnam	Up to \$120,000	Over \$120,000 and up to \$175,000	Over \$175,000 and up to \$250,000
All other counties	Up to \$90,000	Over \$90,000 and up to \$150,000	Over \$150,000 and up to \$250,000

When will I receive my rebate check?

Letters containing details on how to apply will be mailed beginning in mid-July and through the end of September. Applications will be processed as they are received. Rebate checks will be issued in the names (up to three) of those listed as the resident property owners on the application. The Tax Department will mail rebate checks to the mailing address provided on the application.

Homeowners 65-years or older who get the enhanced STAR rebate will receive their checks automatically beginning this summer. Rebate checks will be issued in the names (up to three) of those listed on the assessment rolls for the eligible property. The rebate checks will be mailed to the address provided from the assessment rolls.

Why didn't I receive a Middle Class STAR rebate notification letter?

You will not receive a notification if:

- You did not own the property on the date that the basic STAR exemption application was due to your assessor for your locality for the 2007-2008 school year.
- You did not apply for a STAR exemption at your local assessor's office by the deadline for the STAR application for your locality for the 2007-2008 school year.
- You are eligible for enhanced STAR. You will automatically receive your rebate check and do not have to apply.

- You moved and did not provide the post office with a forwarding address.
- The post office could not deliver your letter to you based on the address provided to the Tax Department.
- Your name and/or property address were not provided to the Tax Department as being enrolled in the STAR program for the 2007-2008 school year.

I think I qualify, but didn't receive a letter, application or STAR code from the Tax Department. What do I do?

Please contact the Tax Department at 1-877-6-STAR-NY (1-877-678-2769). To get a STAR code, you will need the physical address of the property and property identification information from your tax bill.

- For properties outside of New York City, you will need your SWIS code and parcel numbers. This information is available on your school tax bill or by contacting your local assessor.
- For properties in New York City, you will need the borough, block and lot for the property. This information is available on your New York City Department of Finance Statement of Account or at www.nyc.gov.

If you don't have a pre-printed application, you can get a blank application from the Department's Web site or from your local assessor's office.

Will rebate amounts differ within my neighborhood?

Yes. Homeowners within the same neighborhood may not receive the same Middle Class STAR rebate amount. The amount will differ based on the *affiliated income* for each property and whether the property receives a basic STAR exemption or an enhanced STAR exemption.

Do I have to pay tax on my rebate amount when I file my 2007 income tax return?

Generally no; most New Yorkers will not pay tax on the rebate amount. However, if you itemize your deductions when you file your 2007 income tax return, you will have to deduct the amount of the rebate from your property taxes paid. Also, in the unusual case where your rebate is greater than the property taxes you pay, the excess is considered income and needs to be included on your 2007 income tax return.

How does the Tax Department obtain property information?

The Tax Department receives property information for homeowners enrolled in the STAR Exemption Program from the Office of Real Property Services (ORPS) for properties outside of New York City and from the New York City Department of Finance for properties in New York City.

What is the deadline to apply for a 2007 Middle Class STAR rebate check?

The deadline to apply for your rebate is **November 30, 2007**. Late applicants will not receive a rebate check this year.

You only need to apply one time for the rebate and will not need to apply in future years if property ownership remains the same.

A MESSAGE FROM THE NEW YORK STATE TAX COMMISSIONER

Dear New York State Resident Property Owner:

We are pleased to advise you that New York homeowners are eligible this year for real property tax relief through the 2007 Middle Class STAR Rebate Program.

The program provides a tax rebate check to qualifying property owners. The amount of this year's rebate is calculated on a formula that considers an individual's income and local tax burden. Property owners who earn less income will see a larger rebate check.

To receive a rebate, property owners must first receive either the basic or enhanced (senior citizens aged 65 or older) STAR exemption on their school tax bills. Taxpayers who receive the basic STAR exemption must apply for their rebate; enhanced STAR recipients need not apply – they'll get their rebate checks automatically.

The Department of Taxation and Finance is mailing 2.7 million notices to property owners across New York State who qualify as basic STAR recipients, inviting them to apply for their rebate. The application is necessary in order for the Tax Department to be able to link real property information from local assessment rolls to income information to determine the appropriate amount of tax relief.

For administrative purposes, each notice contains a special STAR code unique to the individual property. You will need this code to successfully apply for the rebate. Please wait until you receive your notice from the Tax Department before filing an application.

Filing the application is fast, secure and free. Simply go to the Tax Department's website at www.nystax.gov and file online. This is the quickest way to get your rebate. If you choose not to apply online, file the application by mail.

To receive a rebate check, homeowners only have to verify the property information provided on the application, enter the names, social security numbers, and all required information for all resident property owners and their spouses, verify the mailing address, and submit the application. It's that easy.

The rebate check will be mailed as soon as the application is processed. **The deadline to apply for your Middle Class STAR rebate is November 30, 2007.**

**New York State Homeowners Reminded To Apply for
2007 Middle Class Star Property Tax Rebate**

State officials are reminding homeowners in New York State to apply for their 2007 Middle Class STAR Property Tax Rebate. The rebate is available to qualifying property owners, who file an application with the State Tax Department by November 30, 2007.

The State Tax Department is mailing 2.7 million applications to property owners across New York who receive the basic STAR exemption on their school tax bill. The application is necessary in order for the Department to be able to link real property information from local assessment rolls to income information to determine the appropriate amount of tax relief.

The statewide mailing will be complete by the end of September, allowing people ample time to fill out the application prior to the November 30, 2007, deadline. Once the applications are received, homeowners are encouraged to apply on-line to receive their rebate checks as quickly as possible.

Seniors 65-years or older who receive the enhanced STAR exemption do not have to apply. These homeowners will receive their STAR rebate check automatically.

THE 2007 MIDDLE CLASS STAR REBATE PROGRAM

Governor Spitzer's new Middle Class STAR Rebate Program is an ambitious effort to further reduce the property tax burden on our senior citizens and hard-working families. It is a \$1.3 billion tax cut specifically designed to provide direct relief to New Yorkers who need it most: middle class property owners.

Middle Class STAR is the largest single tax cut for property owners in State history. In order to ensure our working families benefit the most, Middle Class STAR rebate checks will be calculated on a sliding scale based on income.

The maximum benefit will go to all upstate homeowners earning \$90,000 or less, and to all NYC metropolitan region homeowners earning \$120,000 or less. The difference in threshold levels corresponds to the difference in average regional incomes and cost of living. The benefit gradually diminishes as income exceeds these thresholds until a homeowner's income reaches \$250,000. Taxpayers earning over \$250,000 are not eligible for new relief, but will continue to receive their current STAR benefit.

The Tax Department is currently mailing 2.7 million notices to property owners across New York State who receive the basic STAR exemption on their tax bill, inviting them to apply for their rebate. The application is necessary in order for the Department to be able to link real property information from local assessment rolls to income information to determine the appropriate amount of tax relief.

A simple application process makes it easy for families to apply online or by mail.

Seniors 65-years or older who receive the enhanced STAR exemption do not have to apply. These homeowners will receive their STAR rebate check automatically.

The statewide mailing will be complete by the end of September, allowing people ample time to fill out the application prior to the November 30 deadline.

The Tax Department has updated information on the its website, www.nystax.gov, as well as through the Department's Call Center, creating a special hotline at 1-877-6-STAR-NY (1-877-678-2769). Spanish speakers will be able to receive assistance through the Call Center.

Middle Class STAR is a critical component of Governor Spitzer's Renew New York agenda to revitalize the economy, as well as his efforts to support working families and reform our tax base.
