

ALBANY MUNICIPAL WATER FINANCE AUTHORITY MINUTES OF SPECIAL MEETING April 30, 2021

A Special Meeting of the Albany Municipal Water Finance Authority was officially convened at 9:05AM, on April 30, 2021. Pursuant to Executive Order No. 202.1, issued by Governor Cuomo on March 12, 2020, and advisories issued by Federal, State, and Local officials related to the COVID-19 virus, the Albany Municipal Water Finance Authority held the meeting by Zoom conference call. New Business

The purpose of this Special Meeting is to review and discuss proposed Resolution 21-07, a Supplemental Bond Resolution associated with the Long Term Control Plan Phase II - \$46,000,000 – Second Tranche (2018-2022).

Mr. Scott introduced the Resolution and provided a history and background on the original Bond Resolution and the need and purpose of this Supplemental Resolution. This Resolution amends the Bond Resolution approved in June 2017 by amending the approved amount from \$40 million to \$46 million.

Deputy Commissioner Simcoe presented a table illustrating the current actual Long Term Control Plan project costs now that the construction contract costs for the Beaver Creek Clean River Project have been identified. NYSEFC has been approached for additional financing.

Resolutions

Resolution 21-07: Supplemental Bond Resolution associated with the Long Term Control Plan Phase II - \$46,000,000 – Second Tranche (2018-2022. Chairman McEneny called for a motion to approve, which was offered by Mr. Abriel and seconded by Mr. Overdorf. A vote on the motion to approve Resolution 21-07 passed unanimously by Members present.
